This release is intended to discharge in advance Orangevale Recreation & Park District its officers, employees, volunteers, and agents from any and all liability arising out of or connected in any way with my or said minor's participation in said activity, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above. It is further agreed that this waiver, release, and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and hold the above persons or entities free and harmless from any loss, liability, damage, cost, or expense which they may incur as a result of my or said minor's death or an injury or property damage that I or said minor may sustain while participating in said activity.
