DESCRIPTION

Under general supervision by the Pool Manager and Recreation Supervisor, ensures the safety of patrons at the aquatic facility by preventing and responding to emergencies.

1. Maintains constant surveillance of patrons in the facility; acts immediately and appropriately to secure safety of patrons in the event of emergency.
2. Enforce all laws, rules & ordinances as they relate to the facility.
3. Provides emergency care and treatment as required until the arrival of emergency medical services.
4. Always presents professional appearance and attitude and maintains a high standard of customer service.
5. Performs various maintenance duties as directed to maintain a clean and safe facility.
6. Prepares and maintains appropriate activity reports.
7. Performs miscellaneous job-related duties as assigned.

QUALIFICATIONS

CPR certified; Current certification as Lifeguard by a recognized source of training, or proof of in progress certification training.

- Knowledge of and the ability to demonstrate skills in swim lessons instruction
- Ability to work independently and possess energy and enthusiasm
- Current CPR/AED certification preferred or must be acquired within 30 days of hire.

- React calmly and effectively in emergency situations.
- Have skill in the application of lifeguarding surveillance and rescue techniques.
- Pass a pre-employment physical skills evaluation as stipulated by the department.
- Prepare routine administrative paperwork.
- Follow routine verbal and written instructions.
- Have knowledge of customer service standards and procedures.

SPECIAL REQUIREMENTS

- Proof of a negative Tuberculosis screening within the last two years is a pre-requisite for employment.
