**Orangevale Recreation and Park District
Supplemental Questionnaire
Employee or Volunteer Being Considered for
A Position Having Supervisory Authority Over Minors**

Section 5164 of the Public Resources Code of the State of California prohibits ORANGEVALE RECREATION AND PARK DISTRICT from hiring a person for employment at, or hiring a volunteer to perform services at, any of its parks, playgrounds or recreational centers used for recreational purposes in a position having supervisory or disciplinary authority over any minor, if the person has been convicted of certain crimes under the California Penal Code.
