OVparks Community Swimming Pool Rules

The following rules have been established for the benefit and protection of all users. The rules are to ensure safe and sanitary enjoyment of the pool facility. Parents are requested to caution their children to observe all rules and obey instruction of the Lifeguards and other District employees. Failure to comply with these rules may result in the expulsion from the premises, and/or suspension of pool privileges for a period of time that is appropriate for the seriousness of the violation.

1. All patrons must pay to enter the Aquatics facility. Admission will be by payment of appropriate fees or season pass. A family pass is for members of the immediate family, all residing at the same address only.
2. Admission will be refused to anyone with skin lesions, infections, contagious diseases, or wearing bandages.
3. Only clean swim suits will be allowed in the pool. No cutoffs, jean shorts, or street clothes are allowed. No swim suits below the knees. Only specialized swim diapers are allowed in the pool.
4. No masks, fins, inner tubes, balls, toys, water wings, devices that assist children to stay afloat, or other swimming accessories are allowed during open swim hours. Only Coast Guard approved life jackets will be allowed.
5. No chewing gum in pool/deck areas. Hair pins/clips must be removed before entering the water. It is suggested that rings and other jewelry also be removed. Do not leave valuables in the dressing room or visible on deck. OVparks is not responsible for lost or stolen items.
6. Children ten years old and under and who are not of sufficient height to stand in the shallow end of the pool with his/her head above water must be accompanied by someone at least sixteen years or older who will be responsible for the children under ten.
7. No throwing objects, snapping towels, spitting, or blowing one's nose in the pool.
8. NO RUNNING ANYWHERE IN THE POOL AREA. Pushing and rough housing will not be tolerated. Yelling, dunking, wrestling, repeated splashing of other persons or other types of annoying behavior will not be tolerated. Personal conduct in or around the pool facility must be such that safety of self and others is not impaired.
9. If pool capacity falls below twenty patrons, a thirty-minute warning will be given by the Staff. The pool may be subject to closure.
10. In case of unsafe weather conditions (lightning), the pool area may be evacuated until conditions are deemed safe by Staff. Pool access will temporarily be closed in cases when the pool area capacity (400 persons) has been reached.
11. No glass containers allowed. No alcoholic beverages allowed. No smoking allowed in the Aquatics facility. No bicycle, roller blades, skateboards, or pets allowed in the pool/deck areas. Sunglasses and prescription glasses will not be allowed in the water unless they are tied safely around the neck or head.
12. Diving is restricted to designated areas only. There will be no diving in shallow areas of the pool.
13. Slide rules: There will be only one person on the slide area at a time. Participants must wait until the person before has exited the slide area. Sliding must be done on the back with feet first only. Goggles are not allowed down the slide. Parents cannot catch their children coming down the slide. All patrons must exit the slide area immediately.
14. Please do not run into the beach entry area. The railing and ladders are not to be used to hang onto, slide down, jump, or dive over, or play on.
15. Orangevale Recreation & Park District reserves the right to change rules as deemed necessary by Staff. For any further questions, please ask a staff member for assistance.
